Office Circular 4 of 2010

The JPO/IPR Training Program for Fiscal 2010 (For India)

The Office of the CGPDTM has received a request from Japan Institute of Invention and Innovation (JIII) through DIPP requesting for nomination of suitable candidates for the following three programs being organized by the Association for Overseas Technical Scholarship (AOTS).

1) JPO/IPO Training Course for Advanced IP Practitioners July 12 – July 30,2010 (3 weeks). The target participant must meet all the following three requirements. {Application Deadline May 14.05.2010}

- (1) (1) IP practitioners in private business; Employees at corporations involved in planning patent encouragement activities and programs, educating company staff, liaisons for legal affairs relating to licensing, handling patent infringement, patent applications, or investigating prior-art
- (2) Patent attorneys, IP lawyers, or employees at patent/law offices involved in liaisons for legal affairs relating to licensing, handling patent infringement and patent applications, or investigating prior-art.
- (3) IP instructor working at IP Promotional Organizations.
- (2) Target participants should have considerable knowledge of the IPR System as well as desire to acquire knowledge about IPR related work
- (3) Target participants should be between 27 and 50 years of age, with more than 3 years of experience in IPR related work with private business, patent/law office or IP promotional organization.

2) JPO/IPO Training Course for Patent Experts August 25 – September 14,2010 (3 weeks). The target participant must meet all the following three requirements. {Application Deadline May 31, 2009}

- 1) Patent practitioners in private business
- 2) Patent attorneys and IP lawyers
- 3) Persons engaged in patent work at IP Promotional Organizations.
- (2) Target participants should have considerable knowledge of the IPR System as well as desire to acquire more advanced and detailed knowledge about patent related work.

(3) Target participants should be between 27 and 50 years of age, with more than 3 years of actual work experience in drafting specification for patent applications for private business or patent/law office.

3) **JPO/IPO Training Course for IP Trainers September 27 to October 15, 2010 (3 weeks). The target participant must meet all the following three requirements. {Application Deadline July 31, 2009}**

(1) Employee at universities or research institutions involved in education on the Intellectual Property System

Those engaged in the dissemination of the IPR in IP promotional Organization

(2) Target participants should have considerable knowledge of the IPR system as well as desire to acquire knowledge about dissemination of IPR.

(3) Target participants should be between 27 and 50 years of age, with more than three years of experience in work related to the education or dissemination of the IPR system in universities, research institutions or IP promotional Organizations.

Interested candidates who are eligible for the above said programmes should send their CVs along with other necessary documents (in duplicate) to the Controller General of Patents, Designs and Trade Marks, Boudhik Sampada Bhavan, S.M.Road, Mumbai – 400 037, Tel.No.022- 24132735 on or before 14th May, 2010, 21st May, 2010 and 9th July, 2010 respectively. The applications received after the due date will not be processed by this office.


